Note: Applications can be submitted to a maximum of two departments. If you apply to two departments, please indicate your first and second department choices by number on the application form.

#### **Admission Requirements**

- 1. Those who have completed all junior and high school requirements according to school education systems in their residing countries outside Japan, who have qualified for admission to a university, and who have completed more than 12 years of school; or those who have an education equivalent to the above.
- 2. Those who reside outside Japan. (Those who reside in Japan are not eligible to apply.)
- 3. Those who have a score of 200 or higher on the 2015 or 2016 EJU (Japanese language score of maximum 400 excluding the "writing" section) conducted outside Japan.
- 4. Those who are recognized by the president of Osaka International University as qualified applicants who fulfill the requirements listed above.
- \* For the Department of Sports Management, only women can apply.

6	Documents related to payment of expenses	<ul> <li>(1)Expense payment pledge: Official form addressed to the President of Osaka International University completed by an applicant guarantor.</li> <li>(2)Financial support form: Official form addressed to the Director of Osaka Immigration Bureau completed by an applicant guarantor.</li> <li>(3)Certificate of bank account balance (original): Only exchangeable currencies for Japanese yen are valid.</li> <li>(4)Certificate describing the relationship between applicant and guarantor. Any type of form accepted.</li> <li>(Applicants who have nationalities of People's Republic of China, Myanmar and Bangladesh are required to submit other documents in addition to those mentioned above. 7	History of your applications for certificate of eligibility and Japanese Visa (official form)	Complete your application history for the certificate of eligibility and Japanese Visa to enter Japan before you apply to the university.
